

The D-dimer Test is an in vitro diagnostic assay for the quantitative determination of D-dimer in EDTA, lithium heparin or citrate whole blood specimens on the AQT90 FLEX analyzer in point-of-care / near-patient testing and laboratory settings. It is intended for use as an aid in the diagnosis of venous thromboembolism (deep vein thrombosis and pulmonary embolism).

The D-dimer CAL Cartridges are in vitro diagnostic reagents intended for the calibration adjustment of the D-dimer Test on the AQT90 FLEX analyzer by establishing points of reference to estimate D-dimer values.
